Les Flamands securely stores your data at a secured database with our partner Combell NV. Les Flamands will keep your data listed above until you unsubscribe from the newsletter. Once you unsubscribe, we will delete your data by removing all records from our database.

What are your data protection rights?

Les Flamands would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

- The right to access - You have the right to request Les Flamands for copies of your personal data. We may charge you a small fee for this service.
- The right to rectification - You have the right to request that Les Flamands correct any information you believe is inaccurate. You also have the right to request Les Flamands to complete information you believe is incomplete.
- The right to erasure - You have the right to request that Les Flamands erase your personal data, under certain conditions.
- The right to restrict processing - You have the right to request that Les Flamands restrict the processing of your personal data, under certain conditions.
- The right to object to processing - You have the right to object to Les Flamands processing of your personal data, under certain conditions.
- The right to data portability - You have the right to request that Les Flamands transfer the data that we have collected to another organization, or directly to you, under certain conditions.
